The following tables describe the various gender quotas enshrined in the statutes of Italian political parties that have been studied by the Observatory on political parties Aldo di Virgilio from 2001 to 2019. Some of the studied parties are not relevant anymore in the Italian political landscape, while others have consequently modified their statutes (at least in what regards gender quotas) in the last years.

In order to make the reading of the collected data easier, the different parties (with their corresponding statutes) have been classified according to the legislatures during which the studied statutes have been adopted. Five tables are therefore presented in the following pages, each of them being dedicated to a specific legislature, starting from the XIV legislature (2001-2006).

The following information are presented within those tables: the party's coalition at the elections, the (eventual) gender quotas provided for in the various statutes, the object to which apply the aforementioned quotas, and the statute (and the statutes' articles) that enshrines (or not) gender quotas.

For what regards the unavailable statutes, the mention "unavailable data" has been indicated.
